Call to Order

Chairman Massey called the public hearing to Order.

Mr. Moron said this is the first public hearing for the 2016-17 budget. He explained the Finance Department will present an opening statement and then public comments will be taken. Mrs. Erin Griffith, Finance Office, said at this meeting the Board must adopt the tentative budget and tentative millage rate to be advertised according to statutory requirements. She explained it will take 6.3065 mills to fund this budget. She reported the total of the tentative budget is \$50,395,393.00. Mrs. Griffith said the tentative millage rate of 6.3065 is 3.41% greater than the roll back rate of 6.0986. Mrs. Griffith stated the date set for the final budget hearing to adopt the final millage rate and budget for fiscal year 2016-17 is Monday, September 19, 2016 at 5:15 p.m. at the Franklin County Courthouse Annex, County Commission Meeting Room, 34 Forbes Street, Apalachicola, Florida. Chairman Massey asked for public comment. There was no public comment. Mrs. Griffith read the Resolution adopting the tentative millage levy. On motion by Commissioner Lockley, seconded by Commissioner Sanders, and by unanimous vote of the Board present, it was agreed to adopt the Resolution setting the tentative millage levy, as follows:

WHEREAS, the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida, on September 6^{th} , 2016, adopted Fiscal Year 2016-2017 <u>Tentative Millage Rate</u> following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Franklin County has been certified by the County Property Appraiser to the BOARD OF COUNTY COMMISSIONERS as \$1,762,445,742.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida that:

The Fiscal Year 2016-2017 tentatively adopted operating millage rate for Franklin County is **6.3065** mills which is greater than the rolled-back rate of **6.0986** mills by **3.41%**.
