Call to Order

Chair Jones called the meeting to order at 9:00 a.m.

Prayer and Pledge

Chairman Jones led the Board in prayer followed by the Pledge of Allegiance.

Approval of Minutes

A. May 18, 2021, Regular Meeting

On a motion by Commissioner Ward, seconded by Commissioner Parrish, and by a unanimous vote of the Board present, it was agreed to approve the minutes from the meeting held on May 18, 2021. Motion carried 5-0.

Payment of County Bills

On a motion by Commissioner Parrish, seconded by Commissioner Boldt, and by a unanimous vote of the Board present, it was agreed to approve payment of County Bills. Motion carried 5-0.

Public Comments

Mrs. Cheryl Sanders asked the Board to retract their letter of support to the Liberty County Board of County Commissioners in support of the lime rock mine and land swap.

<u>Clerk of Courts – Michele Maxwell – Report</u>

Madam Clerk did not have a report for the Board.

<u>Duke Energy – Danny Collins – Update</u>

B. Mr. Danny Collins will update the Board on recent activities including the Vegetation Management Herbicide Project.

Mr. Danny Collins thanked the Board for leasing the staging site to Jingoli Power and for their continued permission to use Apalachicola Airport for a storm staging site. Mr. Collins announced they will be holding forums for contractors to provide proactive outreach as there are a lot of new builders coming into the area. Mr. Collins said the Eastpoint lighting project should be installed this month weather permitting.

Chairman Jones asked about the vegetation management project. Mr. Collins said they will be doing some vegetation management throughout the county. However, it will not look like it did the last time it was done which was three years ago.

Chairman Jones asked Mr. Collins if other counties have created resolutions recognizing the work Duke Energy has done throughout the region. Mr. Collins said they were awarded one from Citrus County recently. Mr. Collins said he loved working in Franklin County and the standing ovation received at a past FBCC meeting was one of the highlights of his career.

Chairman Jones said he believes the Board should pass a resolution thanking Duke Energy for all of their assistance during and after Hurricane Michael. Mr. Moron agreed and said he believes it would be appropriate to put something in writing to show the Board's support and appreciation for Duke Energy.

Commissioner Boldt made a motion to create a resolution thanking Duke Energy for all of their great work in the entire region, seconded by Commissioner Ward.

Commissioner Parrish said he would like for Mr. Collins to attend the meeting in person to accept it.

Motion carried 5-0.

Commissioner Boldt thanked him for his continued support of the charging systems around the county.

Commissioner Lockley asked if Mr. Collins could repair the lighting around the old IGA. Mr. Collins said he will take a look at it. Mr. Collins said they will get the lighting there and on Bluff Road done as soon as possible.

Superintendent of Roads and Bridges – Howard Nabors

C. Report Informational Item

1. Detail of Work Performed and Material Hauled by District

Mr. Nabors thanked the Board for approving the new trucks. Mr. Nabors noted they have moved into their new office and plan to have a ribbon-cutting in the next few weeks. He said his department has been working on the shoulders of the roads as well as cutting grass. Mr. Nabors said they are still short on inmate labor but they are going to try to get to Hwy 98 this week.

D. Report

Informational Item

1. Right-of-Way Debris Pickup/Recycle Material Hauled Report

Mr. Davis said his department has been busy keeping up with the large beach crowds throughout the county. He said the recycling trucks being used are older and on their last leg. Commissioner Ward asked if staff could check in to leasing trucks. However, Mrs. Griffith said unfortunately companies aren't interested in leasing trucks to the landfill due to the high wear and tear.

Commissioner Lockley made a motion to add purchasing new recycling trucks for the landfill to budget discussions. Commissioner Boldt seconded the motion.

Page | 2 FCBCC Regular Meeting June 1, 2021 Commissioner Boldt said he would like to put money aside for waste management in the future. Chairman Jones said the department heads should be compiling a list of items that may be coming up in the future. Mr. Moron reminded the Board they have requested this information from each of the department heads, a projection of items needed in the next 3-7 years. Commissioner Boldt said he is speaking of purchasing additional land to enlarge the landfill. Commissioner Lockley asked Mr. Davis to get a quote on the trucks so the Board will know what they are looking at.

Motion carried 5-0.

Mr. Davis said he is working on opening the landfill on holidays to prevent a backup of trash pickup.

Mrs. Griffith presented the following item from her report.

1. BOARD ACTION: Use of CARES funds for Landfill Receiver Box Slab Pad Of the first CARES allocation, Franklin County has a remaining balance of approximately \$61,000. At the Franklin County Landfill's transfer station, there is a 66'x33' concrete receiver box slab where the transfer containers for household waste are set to wait for transport to the Springhill landfill for disposal. This slab area was completed several years ago and prevents soil and groundwater contamination by draining the runoff from the transport containers to the sewer system. The containers are very heavy as is the equipment required to move the containers. To protect and preserve the concrete slab and the integrity of the drainage system, welded metal sheeting is needed for the pad area. The market prices of metal sheeting change daily and the current estimate for the materials is \$29,178 with the necessary labor to install the sheeting estimated to be \$4,635. Does the Board want to consider using some of the balance of the first CARES allocation to preserve and protect the receiver box slab at the Landfill? The CARES expenditure worksheet is attached.

Board action to authorize the use of an estimated \$33,813 of the remaining proceeds from the 1st Cares Allocation to preserve and protect the receiver box slab at the landfill.

Moulage may be as simple as applying pre-made rubber or latex "wounds" to a healthy "patient's" limbs, chest, head, etc., or as complex as using makeup and theatre techniques to provide elements of realism (such as blood, vomitus, open fractures, etc.) to the training simulation.

Commissioner Lockley questioned as to if the two companies underbid or if the one company overbid. Mr. Clay Kennedy said all of the quotes were higher than the allotted funds from FEMA. He said the bid alternates are line items that were not previously included in the FEMA damage description but we felt like they needed to be in there. We put those in there to see if they were something FEMA would pay for but kept them separate so that we would have a base bid. Commissioner Parrish said he liked the idea of having parking lot striping. He would like them to request the alternate bid be funded by FEMA.

On a motion by Commissioner Lockley, seconded by Commissioner Boldt, and by a unanimous vote of the Board present, the Board agreed to turn over the bid packages to Mr. Clay Kennedy for review and ranking. Motion carried 5-0.

11. The Franklin County Board of County Commissioners is seeking civil engineering services relating to the construction engineering and inspection (CEI) for the widening and resurfacing improvements on Timber Island Road from U.S. Highway 98 to the end of the road at the Carrabelle River. The total length of the project is approximately 0.9 miles. The scope of the project includes widening the existing roadway from 20' to 24' wide and resurfacing the existing travel lanes, adding 6' wide grassed shoulders, necessary drainage improvements, adding guardrails, and upgrading signage and pavement markings. Consideration will be given to only those firms that are qualified according to law and that have been prequalified by FDOT to perform the indicated types of work.

As this project is federally funded through the Florida Department of Transportation LAP program, FDOT also needed to review and accept the rankings, which they have done so already.

The Corps of Engineers, in consultation with FDEP, told Alan last week that Franklin County will need to obtain an easement from FDEP for the 26 acres Eastpoint Channel Disposal Area. An easement will be needed as the creation of the disposal area is going to turn currently submerged lands into an upland area. The county is already responsible for planting and stabilizing the area. The estimated fee for Dewberry to complete the necessary surveys and application will not exceed \$5,000 and can be paid out of the budget line item for professional services.

Board action to authorize Dewberry Engineers to complete the necessary surveys and application to obtain an easement from FDEP for access to the Eastpoint Channel Disposal Area.

d. BOARD ACTION: Approval to develop bird monitoring plan Two Mile Channel Dredge Project

The disposal area for the Two Mile Channel Dredge project is south of the Apalachicola Regional Airport. Alan was on a conference call last week with the Corps and the FAA and due to the proximity to the airport, the county will need to develop and implement a bird monitoring plan to satisfy the FAA. With approval from the Board, airport engineers AVCON can develop this plan and submit it to county staff for review. The bird monitoring plan is going to require the Board to hire an FAA-qualified biologist for this type of work. When the board dredged the Two Mile Channel some 15 years ago, this same requirement was in place. At that time, the Board contracted with FWC for the use of a licensed 'Bird Harassment Officer' to be on-site during dredging to make sure birds did not congregate at the disposal site. The contract with FWC at that time was for about \$15,000.

Informational Items

f. Board Information: Alligator Drive Hurricane Repair Project

At your last meeting, Alan informed the Board about an FDEP special permitting condition issue that had come up at the pre-construction meeting for the reconstruction of Alligator Drive. The subject special permit condition prohibited construction during Sea Turtle Nesting Season. Franklin County already had a letter from FWC acknowledging that there was no turtle nesting habitat in the area of construction so the special permit condition would and should not have applied, however, the FDEP staff on site were unable to waive the condition without moving up the chain of command at FDEP. Franklin County received formal approval/acknowledgment on Friday that this special permit condition would be waived by FDEP due to the lack of nesting habit. Dewberry Engineers can now move forward with issuing the Notice to Proceed for the reconstruction of Alligator Drive sometime this week.

g. Board Information: Buddy Ward Artificial Reef Project

Walter Marine of Orange Beach, AL will be in Franklin County on or around June 15th for the deployment of the prefabricated articulated reef balls for the Buddy Ward Artificial Reef Project. The deployment is expected to be completed in one day and the Apalachicola Artificial Reef Association will be at the site to fully document and monitor the deployment.

h. Board Information: Preliminary Estimate of Taxable Value

The Franklin County Property Appraiser has provided the Board with a good faith estimate of taxable value for use in the 2021/2022 budget cycle. In the attached, the estimated taxable value

Page | 10 FCBCC Regular Meeting June 1, 2021 of property in Franklin County is \$2,310,915,668 which is an increase of 13.81% in value over the previous year. This percentage of increase fueled by sales data and new construction is the fastest rate of appreciation as seen by Franklin County since the crash of the housing market almost fifteen years ago. The decline in values during the housing crash was so severe that the taxable value of the property today is now just above the taxable value in 2004 which was \$2.107 billion and still 43% less than the taxable value at the high in 2006 when the taxable value was \$4.112 billion. The revenue estimates for state shared revenues and sales tax proceeds will not be released by the Florida Office of Economic Development and Research until sometime in July.

<u>County Coordinator – Michael Morón – Report</u>

13. Report Action Items

a. Airport Manager's Resignation: Mr. Jason Puckett submitted his resignation as your Airport Manager effective today June 1, 2021. My recommendation is to appoint me as your interim Airport Manager. This would allow the Board the opportunity to determine the role and responsibilities of a future Airport Manager, along with a job description and salary before advertising for a permanent candidate. I also recommend transferring the grant and reporting responsibilities, permanently, to Mrs. Erin Griffith, your Fiscal Manager/Grants Coordinator. Board action to accept Mr. Puckett's resignation, appoint me as the interim Airport Manager, and assign Airport grants and report to Mrs. Erin Griffith.

Commissioner Boldt said he would like to see an experienced airport manager temporarily fill in. He has spoken with Mr. Ted Mosteller inquiring to see if he'd be willing to be an interim airport manager.

Commissioner Boldt made a motion to accept Mr. Puckett's resignation and to permanently transfer the grant and reporting responsibilities associated with the airport to Mrs. Erin Griffith. Commissioner Ward seconded the motion. Motion carried 4-1, Commissioner Parrish opposed.

Commissioner Ward asked Mr. Mosteller if he was interested in being the interim airport manager. Mr. Mosteller said that he would be glad to.

On a motion by Commissioner Ward, seconded by Commissioner Boldt, to appoint Mr. Mosteller as the interim airport manager through the end of September 2021. Motion carried 3-2, Commissioner Parrish and Commissioner Lockley opposed.

b. 8 County Oil Spill Administrators' Meeting & Superintendent at July Meeting: I attended the 8 County Oil Spill Administrators' Meeting hosted by Senators Broxon and Gainer on Monday, May 24th. The purpose of the meeting was for all 8 counties to express concerns and suggestions regarding the TRIUMPH application process, with more funded projects as the result. Job creation requirements, clawback clause, increase in infrastructure projects, and small county vs bigger county obstacles were discussed during a closed-door session. Later that afternoon, the Senators invited TRIUMPH representatives, Chairman Don Gaetz, Mr. Rick Harper (Economist), and the Alan Manning General Council to the meeting and presented the concerns and suggestions discussed earlier. During the TRIUMPH representatives dialog and exchange of information, there was one suggestion from the representatives to the 8 counties, especially the smaller counties,

include TRIUMPH in the early stages of planning or considering any project so they can assist with the application process. With that in mind, and based on an offer from Mr. Rick Harper (Economist) to meet with County representatives, I suggest that the Board consider authorizing Chairman Jones, Mrs. Erin Griffith, and I to meet with TRIUMPH representatives to discuss Franklin County's unique issues and perhaps generate some possible projects that TRIUMPH would consider.

On a motion by Commissioner Ward, seconded by Commissioner Boldt, and by a unanimous vote of the Board present, to authorize Chairman Jones, Mrs. Griffith, and Mr. Moron to represent the Board and meet with TRIUMPH representatives to discuss possible projects. Motion carried 5-0.

Inform the Board that Mr. Steve Lanier, Superintendent of Schools, and I talked last week about the "adult vocational" program. Mr. Lanier along with his staff will be at your July 6th meeting to discuss this program in more detail.

Commissioner Lockley asked if Mr. Ted Mosteller would be paid for his role as the interim airport manager.

Motion by Commissioner Lockley, seconded by Commissioner Boldt to pay Mr. Ted Mosteller as the interim airport manager.

Mr. Moron asked Attorney Shuler to give his guidance regarding this matter. Attorney Shuler said he could draft a contract and have it ready for the next board meeting. Commissioner Lockley believes the pay should be equivalent to Mr. Puckett. Attorney Shuler said he is not sure that Mr. Mosteller has the same credentials as Mr. Puckett but it is entirely up to the Board. Commissioner Boldt said he believes Mr. Mosteller has the same knowledge as Mr. Puckett and Mr. Mosteller will be present at the airport. Mr. Mosteller said he appreciates the discussion of payment. However, he has always volunteered for the position of airport manager. He appreciates whatever the Board decides regarding compensation.

Motion carried 3-2, Chairman Jones and Commissioner Parrish opposed.

Mr. Moron confirmed that the motion is for Attorney Shuler to draft a contract based on the Board's direction.

c. Eastpoint USDA Grant: At your March 16, 2021 meeting the Board authorized the Eastpoint Civic Association, by Resolution, to apply for a USDA Rural Business Development Grant to complete an Eastpoint Highway 98 Waterfront and Business Corridor Feasibility Study. The Resolution authorized the elected officers of the Eastpoint Civic Association, Inc. to execute the grant application, agreement, change orders, and other documents related to the grant as signatories for the County. However, Mrs. Betty Webb who made the initial presentation to the Board is of the opinion that since the County is the ultimate responsible party, the Chairman's signature is required on the application and related documents. The application is due in USDA's Marianna office tomorrow by 10 a.m. Mrs. Webb is available virtually to answer any questions.

On a motion by Commissioner Ward, seconded by Commissioner Boldt, and by a unanimous vote of the Board present, to authorize the Chairman's signature on the application and supporting documents for the USDA Rural Business Development Grant. Motion carried 5-0.

Informational Items

d. Courthouse Structure: Based on the Board's request, a structural engineer inspected the courthouse for any indication that undermining issues on Leslie or Forbes Street may cause structural issues in the courthouse. Mr. Lance Watson, Southeastern Consulting Engineers, does not believe that the issues on both roads present an immediate threat to the building's foundation because they are far enough away that they shouldn't impact the structure. However, he recommends that both roads are repaired as soon as possible to prevent further damage to the roadway and that the damage does not extend toward the Courthouse structure. There are some other issues that may have been caused by damaged infrastructure and recent hurricanes/storms that need to be addressed. Mr. Watson and I will be meeting soon to discuss addressing these issues. I will continue to update the Board on this matter.

e. SHIP Funding: Mrs. Lori Switzer-Mills, your SHIP Administrator, participated in a webinar on Thursday, May 20th where she was informed that the County will most likely receive \$350,000.00 for the 2021/22 SHIP allocation. She will update the Board once this information is confirmed.

f. NWFWMD: Attached are the Northwest Florida Water Management District's Annual Wetland report and summary. This report is based on the District's compilation of the status of wetland and related habitat protection in northwest Florida. It includes a cumulative summary of wetland impacts permitted by the Districts' Environmental Resource Permitting (ERP) program with a summary of wetlands and associated water resource lands restored and protected by District's programs.

Commissioner Ward asked Mr. Moron to reach out to the individual at FDOT who is responsible for Hwy 98. She has two areas of concern where the speed limit may need to be reduced and double lines placed. She would also like for Mr. Moron to check on what can be done at the junction of Hwy 67 and Hwy 98 in the downtown area of Carrabelle. Commissioner Ward suggested installing a crosswalk.

Commissioner Boldt said he has similar issues in his district westbound on Hwy 98 at Crooked River Road. He would like to have the speed limit reduced, double lines placed, and possibly a turn lane added.

Mr. Moron asked the Board to send him an email with all of their state road concerns and he will submit one request to FDOT.

Chairman Jones asked Mr. Moron to get a quote for cell phones for the Board. Chairman Jones said he felt like a separate phone device would help in being transparent to the public.

Attorney Shuler asked the Board for direction on the request from Mrs. Sanders to rescind the letter of support sent to Liberty County. Chairman Jones asked if she was wanted us to rescind the letter. Commissioner Boldt said he had lengthy a conversation with the Sanders family and they do want the letter rescinded.

Attorney Shuler said he is waiting for either a letter from Liberty County BOCC or their revised board meeting minutes. This is due to the Board's direction to have something in writing from the BOCC to show their support for the project.

Chairman Jones said since we are waiting on those items from Liberty County he recommends waiting to take action after we received them. Commissioner Boldt said he felt they are spinning their wheels and dragging their feet.

Motion by Commissioner Boldt to rescind the letter of support to Liberty County. Commissioner Parrish said he didn't vote to send the letter to start with so he is not going to make a second. The motion fails for lack of a second.

Chairman Jones said we will wait for Liberty County to provide the documentation previously requested by the Board.

<u>County Attorney – Michael Shuler – Report</u>

14. Report

Action Items:

a. Settlement: Two claims are pending against the Weems EMS. A settlement has been reached without any admission of liability, but your insurance has agreed to settlement terms. The county's only financial responsibility will be the payment of two \$5,000 deductibles. I recommend that you accept the insurance company's recommendation. I have discussed the terms of the settlement with each of you individually.

On a motion by Commissioner Parrish, seconded by Commissioner Lockley, and by a unanimous vote of the Board present, the Board authorized acceptance of the two settlements recommended by the insurance companies. Motion carried 5-0.

a. Enhanced Cleaning of Vacation Rentals: Last year around this time, the board adopted an enhanced cleaning program for vacation rentals so that they could re-open. Now that the Governor has eliminated all China Virus related restrictions, the board should reconsider officially disposing of the enhanced cleaning protocol for vacation rentals.

On a motion by Commissioner Ward, seconded by Commissioner Parrish, and by a unanimous vote of the Board present, the Board agreed to rescind the enhanced cleaning procedures for rental companies. Motion carried 5-0.

a. Land Swap Proposed by the City of Apalach and Land Trust and Request to Release Reverter Clause: The City of Apalach and the Land Trust propose to swap one 60'x100' given by Franklin County to the Land Trust (subject to a reverter clause) for affordable housing to the City in exchange for four 30'x100' lots. For purposes of the City's land development code, the four lots equal two 60'x100' lots; representing two buildable lots being exchanged for one buildable lot. In 2010, Franklin County donated the one 60'x100' lot to the Land Trust for affordable housing subject to a reverter clause which automatically transfers title back to Franklin County if the Land Trust uses it for any other purpose than affordable housing or transfers title. Thus, their request that Franklin County releases the reverter clause. I believe that they want the Land Trust to donate the 60'x100' lot without condition, but on May 29, 2021, I asked for the City Manager and City Attorney to provide me with a written position on this matter.

The Board discussed the issue as to whether the lots were buildable. Commissioner Parrish said he would like assurances from the city that are going to be buildable lots. Cliff Butler said they are more buildable than the one we are giving up.

Commissioner Parrish made a motion to accept the land swap based on Attorney Shuler's recommendation that one of the lots have a reverter clause back to the County and that both lots are buildable.

The Board discussed the location of the two lots which are located on 25th Street behind the Villas. Mr. Butler said the deal would allow for a swap of one lot zoned R-1 for four lots zoned for manufactured housing.

Commissioner Lockley seconded the motion to approve with the provision that Attorney Shuler receives assurances from the City of Apalachicola that the lots are buildable and the reverter clause is included. Motion carried 5-0.

Attorney Shuler noted that a letter was sent to the Department of Revenue regarding the new TDC tax and he has received confirmation of receipt. The new tax will go into effect on July 1st. Commissioner Ward said a couple of people have reached out to her about the leave no trace ordinance noting that there are turtles nesting on beaches other than St. George Island. She suggested we take a look at the current ordinance and revise it to add other locations.

Commissioner Ward made a motion to revisit the Leave No Trace ordinance to include all of the beaches in Franklin County. Commissioner Boldt seconded the motion. Motion carried 5-0.

Non-Action Items:

Jingoli Power: The lease at the airport is waiting on Phase I environmental report. The environmentalist was in the field on May 28, 2021, working on this report.

Commissioners' Comments

None.

H. Update

Ms. Buzbee attended via telephone to give a brief update on the American Rescue Plan. Ms. Buzbee said at this time the information out is not very specific. She noted that you have to look at the entire county budget if you are going to try to capture any revenue loss. She said a possibility may be using some of the funds to match our Hurricane Sally claim or salaries like was done last year with the CARES Act. Ms. Buzbee said that you have to point everything back to COVID and with everything opening up she is not sure how we are going to do that. She recommended the Board develop a plan as to what they want to accomplish. She talked about any new construction being eligible and also retrofitting. We feel its going to be the same as last year. Just want to get the best bang for our buck. Rule that came down, so much information. Ms. Buzbee said she will be getting with Ms. Griffith this week to logon to the system, and in 5-10 days after one half of the funds should be deposited.

Chairman Jones asked if there have been any deadlines or report due dates released. Ms. Buzbee said there will be an interim report due in August and a quarterly report due in October.

Ms. Buzbee said half of the funds will be deposited, then on the next year anniversary we will get the remaining funds. She said she has not heard that we have to spend it by a certain time.

Commissioner Lockley asked if the county employees qualified for any funds noting they have passed out money to all different groups of people. Does the Commissioner's qualify? Ms. Buzbee said that all employees that work for a county are eligible, and you may could increase salary or pay. However, Ms. Buzbee recommends waiting on the guidance to come out before we do that.

Commissioner Boldt suggested utilizing some of the funds for the hospital. Ms. Buzbee said she would have to check on that because the health departments and hospitals received their own funding and we would need to make sure that we aren't using the funds for the same thing.

1. Congressman Dunn's Request: At your April 20th meeting, the Board was informed of Congressman Dunn's request for Congressionally Directed Community Project Funding applications. Mrs. Traci Buzbee, County's Consultant, was tasked with preparing and submitting two applications, construction funding for a new EOC and additional funding for Fort Coombs Armory fire sprinkler system. The County was notified on May 5th that Congressman Dunn submitted the \$1.5 million dollar application for a new EOC construction funding as one of the ten projects he was allowed to submit for funding. Mrs. Buzbee is available to answer additional questions regarding the application. Board discussion and direction.

On a motion by Commissioner Parrish, seconded by Commissioner Lockley, and by a unanimous vote of the Board present, the Board agreed to turn over the RFQ packages to the evaluation committee for review and ranking. Motion carried 5-0.

Mrs. Griffith said the committee should have a ranking to be presented at the next board meeting.

Chairman Jones moved forward on the agenda to the following items:

Fiscal Manager/Grants Coordinator - Erin Griffith - Report

Mr. Pierce presented the following items:

O. Action Items

1. Accept rankings of firms for RESTORE Projects and authorization to negotiate

On Wednesday, May 5th the evaluation committee met and ranked the firms who responded to the RFQs for the County Wide Dune Restoration Project and the St. George Island Storm Water Improvements Project. Upon tabulation of the attached rankings, MRD & Associates was the highest ranked firm for the County Wide Dune Restoration Project and Dewberry and Associates was the highest ranked firm for the St. George Island Storm Water Improvements Project. On May 12th, the county finally received the formal grant award from treasury for the two design grants. As the grants are now approved, county staff can now proceed with negotiations and contract award with the two highest ranked firms.

To avoid confusion with the goal of the projects during the contract negotiations, Alan wants the Board to be aware of what kind of construction budget he thinks is realistic for \$100K worth of design. For both projects, it was Alan's intention that the design projects not only provide recommendations for solutions for each project, but also construction plans and permit applications, where applicable. Due to the significant time delay between application and approval of projects by treasury, Alan wants the design projects to be complete so that the Board and the community can move to construction as quickly as possible.

Dune Restoration- this project covers about 16 miles of beaches. Because of the variability in existing dune and beach profiles around the county, there will mostly likely be multi-pronged design recommendations. The estimated construction budget for dune restoration is \$1 million to \$1.5 million. Alan wants to make sure the Board understands that this is a dune restoration project. In areas where there are no existing dunes or existing beach, like the area in front of the section of Alligator Drive that the county is currently rebuilding, this dune restoration project will not work and those areas are not covered by this project. There must be adequate existing beach present in order to build dunes on a \$1 million dollar budget. The design consultant will evaluate the beaches and make recommendations on appropriate solutions for different scenarios.

St. George Island Storm Water- this project covers the entire business district, which is about 30 acres. There are a few isolated drainage pipes in the district leading to the retention ponds on Franklin Blvd, but those ponds are at capacity and probably treat less than 1/3 of the storm water accumulating in the district. The untreated storm water currently stays on the road surfaces causing failure of asphalt and base as there is no storm water conveyance system except for those leading to the Franklin ponds. The storm water project will analyze the entire district and then prioritize the areas that need improvements first. Alan still wants this design project to result in construction plans that will solve at least some of the storm water problems. The complexity of the solutions will determine how much construction will occur. Alan is estimating a construction budget of \$3 million to \$3.5 million.

There is currently \$9.9 million at Treasury for Franklin County. The design and construction of these 2 projects would use about \$5 million of the current funds. Next April another \$1.2 million will be put into the Treasury in accordance to the settlement worked out by the federal

government and BP. Over 15 years, the Board will receive some \$22 million of RESTORE funds, so as the funds come in the Board can continue to develop projects. Treasury will not approve projects in excess of the funds available so the Board will need to work within the funds available.

Alan has talked to the Board in the past about a beach restoration project that would build about one mile of beach in front of the Alligator Drive washout. The total budget for this project has been estimated by Mike Dombrowski of MRD and Associates at \$10 million, with \$5 million of RESTORE funds matched by \$5 million of FDEP funds. Franklin County has requested \$200,000 from FDEP this year to finish the design of the beach project. The county has not been notified whether those funds were allocated by the Legislature. If granted it could be possible that in 2023, or 2024, the county would be in the position to request \$5 million from FDEP for construction of the beach, which in turn would mean the Board would need \$5 million of RESTORE as a match. Of course, the issue of who pays for the maintenance of the beach will still need to be resolved before the county could commit to building a beach.

On a motion by Commissioner Lockley, seconded by Commissioner Parrish, to accept the rankings of the evaluation committee and to authorize staff to negotiate with the two highest ranked firms for the two RESTORE design grants.

Commissioner Lockley asked if this money could be used for the hospital. Mr. Pierce said the BP RESTORE money was sent to solve environmental reparation, infrastructure and economic development. Mr. Pierce noted that early on the county tried to get the hospital funded and they didn't approve because it didn't meet their stipulations. The hospital was not impacted by the oil spill. Mr. Pierce said there was several things that were completely off the table like building new county offices and schools. Commissioner Parrish said he thought there was a limit and Mr. Pierce said yes that may have been what it was.

Commissioner Boldt thanked Mr. Pierce for his work on the beach restoration project.

Motion carried 5-0.

2. Gulf Council Letter for Dredging Projects

Alan has been working with the Consortium to resolve issues raised by the Gulf Council concerning our dredging projects. Please find attached the questions from the Gulf Council, and the joint response from Alan and the Corps. After the Gulf Council reviewed the response, they then asked for a letter on county letterhead confirming the county will be responsible for any non-federal cost over-runs above \$5 million dollars. Alan has drafted a letter and it is also attached. The Board needs to approve this letter, or some form of it, and have Alan send it to the Gulf Council.

Just for information, Alan had a teleconference call last week with Mr. John Collins, AVCON, and the Corps of Engineers regarding the status of the FDEP permit for the Two Mile Channel. The Corps believes that FDEP will find the Corps application to be complete by the end of May, and then FDEP will have a statutorily limited time to review and issue the permit. Just like the Eastpoint Channel, the Corps says the dredging of Two Mile will take place in the fall.

On a motion by Commissioner Ward, seconded by Commissioner Lockley, and by a unanimous vote of the Board present, to approve the draft letter in regards to cost overruns for the dredging projects and send to the Gulf Coast Consortium as written. Motion carried 5-0.

Mrs. Griffith presented the following items:

3. Grant Resolutions Florida Historic Preservation Grants

Requesting adoption of the attached two resolutions supporting the grant applications for the Florida Historic Preservation Grant Program for the Carrabelle Beach Wayside Park

Restoration Project and the Buddy Ward Maritime Museum Project. The applications are due on June 1st and documented community support is needed for the two projects

On a motion by Commissioner Ward, seconded by Commissioner Parrish, to adopt the two resolutions supporting the Florida Historic Preservation Grant Program applications. Motion carried 5-0.

4. Rolling Dump Truck Lease - Road Department

It is time to renew the rolling dump truck lease-purchase agreement for the Franklin County Road Department. Eight surrounding rural counties participated in this same program previously through Capital Truck of Tallahassee including Liberty, Madison, Suwanee, Taylor, Holmes and Calhoun. Unfortunately, this past year, Capital Truck of Tallahassee filed Chapter 11 Bankruptcy. The Mack dealership is now owned by Nextran and Nextran does not offer the same arrangement in place by Capital City as they are unable to guarantee the buyback price of the trucks. The buyback will occur at market pricing at the time of disposal. The 2021 cost of a new heavy-duty dump truck is \$154,697 per truck. The new structure will have the county owning the trucks for up to twenty-six months with making the first lease payment of \$15,000 per truck as in the previous agreement with the second year payment increasing to \$17,500 per truck. Before the third payment, the trucks will be returned to Nextran and replaced with two new model year dump trucks. This program allows the road department to have reliable dump trucks, covered by an added extended warranty with little maintenance expense year after year. This is the fourth renewal of the rolling lease program with some changes to the previous structure with new vendor Nextran.

Commissioner Lockley asked if they had money in their budget and Mrs. Griffith confirmed.

On a motion by Commissioner Lockley, seconded by Commissioner Ward and Boldt, to approve the attached resolution and authorization for the Chairman to sign the six year lease purchase agreement with Leasing 2 to finance the purchase of two new dump trucks in the amount of \$319,245.72 from Nextran of Tallahassee and the trade-in of the 2020 trucks, county property tag numbers A005451 and A005452 subject to review and approval of the agreement by County Attorney Michael Shuler.

Commissioner Ward said she felt the \$2,500 difference would be made up by the cost of maintenance on the trucks. Chairman Jones thanked Mrs. Griffith for her extensive research on this project and reiterated that this is the best deal that we can get. Commissioner Boldt said he thought that by leasing the trucks it helps our funds to go further.

Motion carried 5-0.

P. Informational Items

1. Sweeper Truck Status Update

On January 20, 2021 Franklin County issued a purchase order for the Sweeper Truck. The truck was initially supposed to be delivered in March, then delays in manufacturing caused by the Coronavirus Pandemic moved the anticipated delivery date to May and now back until sometime in June. I will keep the Board informed as to any additional changes in the anticipated delivery date.

2. Second Installment of Coronavirus Relief Funding for Airport

Franklin County was recently notified of a second round of Coronavirus Relief funding through the FAA to help offset a decline in revenues arising from diminished airport operations and activities as a result of the COVID-19 public health emergency. The funds provided can only be used for purposes directly related to the airport and can include the reimbursement of an airport's operation and maintenance expenses. The county is working on the application at



this time for these funds. The first award was \$30,000 through CARES and was used to offset the annual cost of property insurance for the airport.

Mr. Moron presented the following items at this time:

O. Action Items

2. TRIUMPH Meeting List: At your last meeting the Board discussed State Senator Doug Broxson's invitation to attend an 8 County Oil Spill Administrator's meeting on Monday, May 24th at 12:30 p.m. (ET) at the Walton County Courthouse Annex in Santa Rosa Beach. The Board agreed to create a list of projects that could be funded by TRIUMPH funds set aside for Franklin County. The current list of projects includes an additional wing to Weems Hospital, completion of the Coombs Armory renovation project, Broadband infrastructure project, and a trust fund for maintenance dredging of the Eastpoint Channel and 2-mile Channel. Will the Board add any additional projects to the list? Board discussion and direction.

Chairman Jones suggested requesting additional funding for the new EOC building. Commissioner Ward suggested requesting funding for a cell phone tower on Highway 65. Commissioner Boldt suggested finding out how the county could partner with Alligator Point or the City of Carrabelle to apply for funding for a fire suppression system along Highway 98 from Alligator Point past St. Teresa.

Mr. Moron informed the Board that he has received several calls regarding the welding program at the Franklin County School and when it would be offering classes to the adult population. Mr. Moron asked for Board permission to reach out to Superintendent Lanier requesting a plan on how and when the school board plans to facilitate the classes. Mr. Moron said this was part of the agreement when the Board supported the program as it would help to provide a trained workforce for our community.

Commissioner Parrish said these projects are not listed as to classifications. Mr. Moron said his overall message is you can't treat the rural counties the same as the urban counties. How much of our county is owned by state and county? Commissioner Boldt said look at what good stewards we are of the money that is sent here and look at how we have taken care of our obsolete infrastructure. Commissioner Lockley said we need to do something, the bay is dead and all we have is tourism. If we want people to stay here we have to do something.

Chairman Jones met with John from AVCON and discussed things that can be done at the airport. Mr. Puckett mentioned international freight at the last meeting. Chairman Jones said that it was never his intentions to facilitate international freight. Chairman Jones said what he would like to check on is what it would take to allow freight cargo to come in. He said he knew the runway would have to be extended and made thicker. He also mentioned adding a railroad spur. Just a general discussion of what we can do with the funds to enhance the airport.

Commissioner Boldt said he has noticed that Triumph looks favorly upon projects where multiple counties are working together.

Commissioner Lockley said he thinks we need to get something going on our own. We need something here, we need an economic development council.

Motion by Commissioner Lockley to create an Economic Development Council.

Mr. Moron said the last time an EDC didn't work well. Chairman Jones said the ARPC was tasked with creating a plan and it has been created. They were waiting on the Board to be ready for the idea before they presented it. Mr. Moron asked if the plan could be brought before the Board and then created. Commissioner Lockley said no, he would like the Board to act now.



Chairman Jones said Mrs. Griffith is the county's grant manager. Mr. Pierce said our county staff is very knowledgeable in grants and what funds are available. Mr. Pierce noted the Board employs Ms. Traci Buzbee, and an additional full time staff member would be a lot of tax payer's money. In a way you already have that it is just in the way of consultants. Mr. Moron said since ARPC already drafted a plan perhaps the Board could listen to the presentation and decide what is needed for the county. Mr. Pierce noted that Gulf County has run through several EDCs.

Commissioner Ward asked who would be a part of this board. She said a lot of the boards are volunteer and we don't want an issue with people not showing up and not having have a quorum.

Commissioner Lockley said he was talking about opening up an office with a director to provide production to bring in some companies for people to work. If they don't bring in any jobs then they'll have to go.

Mr. Moron asked Commissioner Lockley if he was asking the board to add this new position to their budget.

Commissioner Lockley said you have these in every county and they have been productive. Commissioner Lockley noted that people have to leave town in order to get a job they can't look forward to staying here.

Chairman Jones announced there was a motion on the floor to add an Economic Development Council position to next year's budget. Seconded by Commissioner Boldt, opposed by Commissioner Ward. Motion carried 4-1.

3. Building Official: I am happy to report the Mr. Steve Paterson has received his Provisional Building Official (Code Administrator) license which allows him to assume the role as the County Building Official. He will have one year to pass an additional test that will remove the Provisional status. I am recommending an annual salary of \$50,000 for Mr. Patterson as your Building Official effective March 15th, as the County will not renew Mr. Garry Millender's contract for Building Official services. Board action to approve a \$50,000 salary for Mr. Paterson as the County's Building Official.

On a motion by Commissioner Boldt, seconded by Commissioner Ward, to approve a \$50,000 salary for Mr. Paterson as the County's Building Official.

Chairman Jones asked if there were funds in the budget. Mr. Moron said there was extra due to Mr. Millender's contract no longer being needed.

Commissioner Lockley asked what Mr. Millender was making, and Mrs. Griffith and Mr. Pierce said it was about the same.

Motion carried 5-0.

4. Eastpoint Streetlights: The Eastpoint Civic Association would like to install 16 streetlights on US 98 in Eastpoint between 2nd and Bayshore. It would light the area in Eastpoint that is considered the Business District with the most pedestrian traffic across Highway 98. Over the years there have been a number of traffic accidents, some including pedestrians, at this location. In addition, increased lighting reduces crime and drug activity. Duke Energy's proposal to install these 16 streetlights has a \$344.00 upfront deposit cost and has a \$171.84 monthly recurring fee. With a few exceptions, the Board has turned down past requests for streetlights in more rural and secluded areas of the County, but keep in mind this request is along Highway 98 on a heavily traveled area. I have asked FDOT to look at the streetlight proposal to determine if, based on their criteria, there is adequate lighting. If FDOT determines there isn't adequate lighting, they may add streetlights in this area at their expense therefore reducing the number of lights that the Eastpoint Civic Association would requesting for Board consideration. Board discussion and direction.

Mr. Moron said the Board would need to add this item into the new budget.

Commissioner Parrish said he would like to have them on Bluff Road, noting how dark it is, and that his grandson was killed on this road. If we are going to do it let's do it for both roads. Commissioner Parrish said Bluff Road is a very high traffic area and noted there have been several fatal accidents on this road. Commissioner Parrish said he has brought this up on several occasions and it needs to be taken care of. He is not opposed to installing the lights in Eastpoint but thinks we need them on Bluff Road as well.

Commissioner Lockley made a motion that we install the streetlights as requested in Eastpoint and Bluff Road.

Chairman Jones said the Board would need to adopt a policy for the future so that we could add a line item on the budget. He suggested including language that confirms support from the Sheriff and Superintendent of Schools for safety.

Commissioner Lockley amended the motion to approve installing the streetlights in Eastpoint and on Bluff Road, and to create a policy for the Board to approve for future use. Motion seconded by Commissioner Ward.

Commissioner Parrish said the lights need to start right past the cemetery where there are currently no lights.

Mr. Moron said that FDOT is looking at proposal and it may be less cost to the County if they agree to pay for some of them.

Motion carried 5-0.

The meeting recessed at 10:31 a.m. and resumed at 10:44 a.m.

Motion carried 5-0.

5. Flood Ordinance Public Hearing: Mrs. Angela Lolley, the County's Floodplain Manager, is ready to proceed with the Flood Ordinance process. Mrs. Lolley has been working extensively with the FEMA representative on the ordinance. The next step is to schedule a public hearing to discuss the draft ordinance. Board action authorizing Attorney Shuler to schedule and advertise a public hearing for the Flood Ordinance.

On a motion by Commissioner Ward, seconded by Commissioner Boldt, and by a unanimous vote of the Board present, the Board authorized Attorney Shuler to schedule and advertise a public hearing for the Flood Ordinance. Motion carried 5-0.

6. County Beach Parking Workshop: At your last meeting there was Board action to schedule a workshop to discuss the County's beach parking issues before we proceed with changing the ordinance. Staff, as directed in that same action, is in the process of contacting towing companies in Wakulla and Leon counties about providing weekend "roam and tow" services on Alligator Point. I am in the process of creating the June agendas and would like some consensus if the Board wants this workshop during the regular meeting agenda or at 1:30 p.m. (ET) after one of your regular meetings in June. Board discussion and direction.



Chairman Jones, Commissioner Parrish and Commissioner Ward said they would like to have the workshop after a regular board meeting.

Commissioner Parrish asked if the Board would have information to discuss by this time. Is there sufficient violations for the towing companies to come down? If the towing company is coming in to make money and they aren't coming, then something is wrong. There has to be a reason if a towing company doesn't want to go down there and make money. Commissioner Parrish said that we need to have information to talk about if we are going to hold a workshop.

Commissioner Ward said she believes a workshop would be beneficial to bounce ideas off of each other. For example, the issue with the payment of booting. If we are going to boot vehicles then how it is going to be facilitated? How are they going to move the boots from place to place, how are they going to accept payments? There is a lot more in to play with the workshop, besides the tow trucks. Commissioner Ward said that we need signage to designate parking spots and maybe get a list of where we need to place these signs.

Chairman Jones said he agrees we need to discuss how many spots are designated for each area. We have an ordinance that allows for a vendor to park on any right away but we are talking of towing vehicles.

Commissioner Ward said the Board should contact Major Coulter and see if there are any private booting companies that are willing to come down. She suggested asking Mr. Nabors to attend the workshop to discuss installing the signs.

Commissioner Boldt noted that he made a recommendation at the last meeting to conduct a survey to see if any private towing companies were willing to come down.

Commissioner Parrish said while we are working up to this workshop if parking is such an issue the Board needs documentation and pictures. How often does it happen? Commissioner Parris said he hasn't seen any pictures of the issues and he only knows what he saw when he went there. He said the Board needs actual proof that an issue is going on in order to act accordingly. The Board needs this documentation prior to the workshop so that we have something to talk about. Commissioner Parrish said in St Augustine they built a large parking garage. Is that something we really need to be looking into?

The consensus of the Board was to hold the workshop on June 15th @ 1:30.

Chairman Jones reminded the Board and anyone who was listening, that there will be no board action at the workshop.

Public comments:

Mr. Jason White, owner of Jason White Construction, asked the Board to clarify what type of road services the County is going to do and how it would compete with local contractors.

Attorney Shuler said the Board is not getting into the road maintenance business. Historically, the County has denied repairing any private roads and they are not allowed to use funds from ad valorem taxes to do so. Attorney Shuler said it would be limited maintenance however he would consider it to be competition with private businesses. The services would be limited to maintenance to ensure roads are safe for passing of emergency vehicles and public services. Attorney Shuler said if a property owner wanted to bring their road up to county road standards they would have to obtain a private contractor to do so. There is strict limitation of one annual service not to exceed \$1000 which excludes driveways. Attorney Shuler said basically what they have now is what they will have in the future.

Commissioner Parrish asked Mr. White if he felt this ordinance would hurt his business. Mr. White said he was thinking it through but he felt that he would be competing with the county on road work. Commissioner Parrish asked Mr. White if he was able to respond to people when they call for road work. Mr. White said he employs 25 people and they bid on a lot of roads. Chairman Jones said in trying to adopt this ordinance, it was basically giving the county a way to do limited maintenance on a private road in order for emergency vehicles, busses and public services. Commissioner Lockley said we need to let the public know that the county isn't in competition with the private sector. We are only trying to repair roads in order to keep them from tearing county vehicles up.

Commissioner Boldt made a motion to approve the ordinance as written. The motion fails for lack of a second.

Attorney Shuler said the Board could close the public hearing without approving the ordinance without any further comments.

Commissioner Boldt explained that he made a motion to approve because the county is responsible for public safety for ambulances, fire, school busses, and police.

Commissioner Ward said she had reached out to residents on Buck Road and they said it's cheaper for them to pay the private contractors than to pay the county. The residents also noted the private contractors have provided free services on Buck Road when it becomes unpassable. She said this s why she didn't second the motion.

Commissioner Parrish said these are good people. He noted that both Timmy and Jason came in and helped after the fire in Eastpoint. They are going to work with people, keep our constituents employed. Commissioner Parrish said that they could probably do it cheaper than the county. He also noted that in the proposed ordinance the homeowner would have been required to pay the county for the services upfront. Chairman Jones said that Timmy Butler with Coastline Clearing oftentimes grades Buck Road at no charge. Commissioner Ward thanked Mr. Butler for helping the residents on Buck Road.

Items 5-7 previously addressed.

5. Flood Ordinance Public Hearing: Mrs. Angela Lolley, the County's Floodplain Manager, is ready to proceed with the Flood Ordinance process. Mrs. Lolley has been working extensively with the FEMA representative on the ordinance. The next step is to schedule a public hearing to discuss the draft ordinance. Fiscal Manager/Grants Coordinator - Erin Griffith - Report

O. Action Items

1. Accept rankings of firms for RESTORE Projects and authorization to negotiate

On Wednesday, May 5th the evaluation committee met and ranked the firms who responded to the RFQs for the County Wide Dune Restoration Project and the St. George Island Storm Water Improvements Project. Upon tabulation of the attached rankings, MRD & Associates was the highest ranked firm for the County Wide Dune Restoration Project and Dewberry and Associates was the highest ranked firm for the St. George Island Storm Water Improvements Project. On May 12th, the county finally received the formal grant award from treasury for the two design grants. As the grants are now approved, county staff can now proceed with negotiations and contract award with the two highest ranked firms.

To avoid confusion with the goal of the projects during the contract negotiations, Alan wants the Board to be aware of what kind of construction budget he thinks is realistic for \$100K worth of design. For both projects, it was Alan's intention that the design projects not only provide recommendations for solutions for each project, but also construction plans and permit applications, where applicable. Due to the significant time delay between application and approval of projects by treasury, Alan wants the design projects to be complete so that the Board and the community can move to construction as quickly as possible.



Dune Restoration- this project covers about 16 miles of beaches. Because of the variability in existing dune and beach profiles around the county, there will mostly likely be multi-pronged design recommendations. The estimated construction budget for dune restoration is \$1 million to \$1.5 million. Alan wants to make sure the Board understands that this is a dune restoration project. In areas where there are no existing dunes or existing beach, like the area in front of the section of Alligator Drive that the county is currently rebuilding, this dune restoration project will not work and those areas are not covered by this project. There must be adequate existing beach present in order to build dunes on a \$1 million dollar budget. The design consultant will evaluate the beaches and make recommendations on appropriate solutions for different scenarios.

St. George Island Storm Water- this project covers the entire business district, which is about 30 acres. There are a few isolated drainage pipes in the district leading to the retention ponds on Franklin Blvd, but those ponds are at capacity and probably treat less than 1/3 of the storm water accumulating in the district. The untreated storm water currently stays on the road surfaces causing failure of asphalt and base as there is no storm water conveyance system except for those leading to the Franklin ponds. The storm water project will analyze the entire district and then prioritize the areas that need improvements first. Alan still wants this design project to result in construction plans that will solve at least some of the storm water problems. The complexity of the solutions will determine how much construction will occur. Alan is estimating a construction budget of \$3 million to \$3.5 million.

There is currently \$9.9 million at Treasury for Franklin County. The design and construction of these 2 projects would use about \$5 million of the current funds. Next April another \$1.2 million will be put into the Treasury in accordance to the settlement worked out by the federal government and BP. Over 15 years, the Board will receive some \$22 million of RESTORE funds, so as the funds come in the Board can continue to develop projects. Treasury will not approve projects in excess of the funds available so the Board will need to work within the funds available.

Alan has talked to the Board in the past about a beach restoration project that would build about one mile of beach in front of the Alligator Drive washout. The total budget for this project has been estimated by Mike Dombrowski of MRD and Associates at \$10 million, with \$5 million of RESTORE funds matched by \$5 million of FDEP funds. Franklin County has requested \$200,000 from FDEP this year to finish the design of the beach project. The county has not been notified whether those funds were allocated by the Legislature. If granted it could be possible that in 2023, or 2024, the county would be in the position to request \$5 million from FDEP for construction of the beach, which in turn would mean the Board would need \$5 million of RESTORE as a match. Of course, the issue of who pays for the maintenance of the beach will still need to be resolved before the county could commit to building a beach.

2. Gulf Council Letter for Dredging Projects

Alan has been working with the Consortium to resolve issues raised by the Gulf Council concerning our dredging projects. Please find attached the questions from the Gulf Council, and the joint response from Alan and the Corps. After the Gulf Council reviewed the response, they then asked for a letter on county letterhead confirming the county will be responsible for any non-federal cost over-runs above \$5 million dollars. Alan has drafted a letter and it is also attached. The Board needs to approve this letter, or some form of it, and have Alan send it to the Gulf Council.

Just for information, Alan had a teleconference call last week with Mr. John Collins, AVCON, and the Corps of Engineers regarding the status of the FDEP permit for the Two Mile Channel. The Corps believes that FDEP will find the Corps application to be complete by the end of May, and then FDEP will have a statutorily limited time to review and issue the permit. Just like the Eastpoint Channel, the Corps says the dredging of Two Mile will take place in the fall.

3. Grant Resolutions Florida Historic Preservation Grants

Requesting adoption of the attached two resolutions supporting the grant applications for the Florida Historic Preservation Grant Program for the Carrabelle Beach Wayside Park Restoration Project and the Buddy Ward Maritime Museum Project. The applications are due on June 1st and documented community support is needed for the two project

4. Rolling Dump Truck Lease - Road Department

It is time to renew the rolling dump truck lease-purchase agreement for the Franklin County Road Department. Eight surrounding rural counties participated in this same program previously through Capital Truck of Tallahassee including Liberty, Madison, Suwanee, Taylor, Holmes and Calhoun. Unfortunately, this past year, Capital Truck of Tallahassee filed Chapter 11 Bankruptcy. The Mack dealership is now owned by Nextran and Nextran does not offer the same arrangement in place by Capital City as they are unable to guarantee the buyback price of the trucks. The buyback will occur at market pricing at the time of disposal. The 2021 cost of a new heavy-duty dump truck is \$154,697 per truck. The new structure will have the county owning the trucks for up to twenty-six months with making the first lease payment of \$15,000 per truck as in the previous agreement with the second year payment increasing to \$17,500 per truck. Before the third payment, the trucks will be returned to Nextran and replaced with two new model year dump trucks. This program allows the road department to have reliable dump trucks, covered by an added extended warranty with little maintenance expense year after year. This is the fourth renewal of the rolling lease program with some changes to the previous structure with new vendor Nextran.

P. Informational Items

1. Sweeper Truck Status Update

On January 20, 2021 Franklin County issued a purchase order for the Sweeper Truck. The truck was initially supposed to be delivered in March, then delays in manufacturing caused by the Coronavirus Pandemic moved the anticipated delivery date to May and now back until sometime in June. I will keep the Board informed as to any additional changes in the anticipated delivery date.

2. Second Installment of Coronavirus Relief Funding for Airport

Franklin County was recently notified of a second round of Coronavirus Relief funding through the FAA to help offset a decline in revenues arising from diminished airport operations and activities as a result of the COVID-19 public health emergency. The funds provided can only be used for purposes directly related to the airport and can include the reimbursement of an airport's operation and maintenance expenses. The county is working on the application at this time for these funds. The first award was \$30,000 through CARES and was used to offset the annual cost of property insurance for the airport.

County Coordinator - Michael Morón - Report

O. Action Items

1. Congressman Dunn's Request: At your April 20th meeting, the Board was informed of Congressman Dunn's request for Congressionally Directed Community Project Funding applications. Mrs. Traci Buzbee, County's Consultant, was tasked with preparing and submitting two applications, construction funding for a new EOC and additional funding for Fort Coombs Armory fire sprinkler system. The County was notified on May 5th that Congressman Dunn submitted the \$1.5 million dollar application for a new EOC construction funding as one of the ten projects he was allowed to submit for funding. Mrs. Buzbee is

- 2. TRIUMPH Meeting List: At your last meeting the Board discussed State Senator Doug Broxson's invitation to attend an 8 County Oil Spill Administrator's meeting on Monday, May 24th at 12:30 p.m. (ET) at the Walton County Courthouse Annex in Santa Rosa Beach. The Board agreed to create a list of projects that could be funded by TRIUMPH funds set aside for Franklin County. The current list of projects includes an additional wing to Weems Hospital, completion of the Coombs Armory renovation project, Broadband infrastructure project, and a trust fund for maintenance dredging of the Eastpoint Channel and 2-mile Channel. Will the Board add any additional projects to the list? Board discussion and direction.
- 3. Building Official: I am happy to report the Mr. Steve Paterson has received his Provisional Building Official (Code Administrator) license which allows him to assume the role as the County Building Official. He will have one year to pass an additional test that will remove the Provisional status. I am recommending an annual salary of \$50,000 for Mr. Patterson as your Building Official effective March 15th, as the County will not renew Mr. Garry Millender's contract for Building Official services. Board action to approve a \$50,000 salary for Mr. Paterson as the County's Building Official.
- 4. Eastpoint Streetlights: The Eastpoint Civic Association would like to install 16 streetlights on US 98 in Eastpoint between 2nd and Bayshore. It would light the area in Eastpoint that is considered the Business District with the most pedestrian traffic across Highway 98. Over the years there have been a number of traffic accidents, some including pedestrians, at this location. In addition, increased lighting reduces crime and drug activity. Duke Energy's proposal to install these 16 streetlights has a \$344.00 upfront deposit cost and has a \$171.84 monthly recurring fee. With a few exceptions, the Board has turned down past requests for streetlights in more rural and secluded areas of the County, but keep in mind this request is along Highway 98 on a heavily traveled area. I have asked FDOT to look at the streetlight proposal to determine if, based on their criteria, there is adequate lighting. If FDOT determines there isn't adequate lighting, they may add streetlights in this area at their expense therefore reducing the number of lights that the Eastpoint Civic Association would requesting for Board consideration. County Attorney - Michael Shuler - Report

No report.

Commissioners' Comments

Chairman Jones and Commissioner Parrish said they have had complaints about the LMS meetings not being held. Mr. Moron said he would contact Mrs. Brownell and report back.

Chairman Jones said the homeowner at 301 W Gulf Beach Drive has cleared the County's entire twenty-five feet of right of way when creating their driveway. Attorney Shuler instructed Mr. Moron to send a letter to the property owners stating the issue and notifying them they will need to revegetate the property. If the matter cannot be worked out, Mr. Moron will defer the issue to Attorney Shuler.

Chairman Jones said there is an issue at Regatta Park where after the bars close people gather there to continue partying. The issue has caused a lot of interaction with law enforcement and grief to the nearby residential neighbors. Chairman Jones suggested closing the park or installing a fence that is closed at dusk. Mr. Moron will contact Mr. Davis and come up with a solution.

Mr. Pierce clarified that the second installment of Coronavirus Relief Funding for the airport will be for \$9,000.00 and not the previously awarded \$30,000.00.

Mr. Moron asked the Board if there was anything they could do to help Mr. Rogers. He's had an application in with the Board of Adjustment for over three months. Attorney Shuler said it was his understanding that the setback request was tabled. After reviewing the site plan, one of the BOA board members suggested that the house be moved further west to the pole barn. In doing so it is possible a setback may not be required. The house is outside of the critical habitat but the deck is inside of the critical habitat. Attorney Shuler





reported that at the meeting the members could not agree, the item was tabled and sent back to the applicant to review their comments. The issue is having a meeting with only three members in attendance. Attorney Shuler said he would not recommend the BOCC bypassing the BOA this stage. Commissioner Ward said that she knows Mr. Rogers is trying to alleviate the issues and appreciates Attorney Shuler's comments. Commissioner Boldt said what about considering a special master instead of a volunteer board to oversee the BOA. He noted that often times there is not a quorum at these meetings. Chairman Jones said a lot of the issues we have talked about today have been growth issues. He said he is not sure if special master would be a better solution but it may be something the Board can consider. Mr. Moron said we are having a problem with volunteer boards.

Commissioner Ward said that is why she didn't vote for the EDC because she wasn't in agreement with paying a board. She could see where there may be an issue with people not showing up and realizes the frustration for those who do show up. Mr. Moron said most of the time you have three members who show up for meetings.

Commissioner Boldt made a motion for the County Coordinator to explore the idea of a Special Master.

Attorney Shuler said if there is a second he would like this motion amended to say he will explore this as it is out of Mr. Moron's realm.

Commissioner Parrish said he felt this is going to be an outside person who doesn't know anything about Franklin County, and that this one person will be taking away the Commissioners and the various board's recommendation. He said most of them give a recommendation and you better have a good factual basis for not taking their recommendation. Commissioner Boldt said he doesn't feel like his authority is being taken at all. Mr. Pierce said the community driven boards play a vital role. He said we should encourage more people to be on them.

Attorney Shuler asked Commissioner Boldt if he would defer his motion until they can have a conversation and then bring back to the Board if necessary. **Commissioner Boldt agreed to defer his motion.**

Commissioner Lockley said he wasn't talking about bringing anything in house with the EDC, but setting it up separately. Chairman Jones said that the ARPC has a plan ready to present to the Board and they were just waiting until the Board expressed interest in it. It would be similar to the TDC. Commissioner Parrish asked that Mr. Moron advertise the positions that are available for the P&Z and BOA boards. He suggested putting it in the newspaper and radio as a public service announcement. Commissioner Ward said there is a vacancy on the Weems Board yet there is no public interest.

Commissioner Parrish asked Mr. Moron to write something up that will give the volunteers a sense of pride to serve the community and provide input. Mr. Pierce noted there has always been an issue with getting people to volunteer for boards. He said in 1988 they would serve hamburgers at the meetings to encourage board members to attend.

Dear Commissioners:

Alligator Point Water Resources District ("APWRD" or "District") is an independent special district located in Alligator Point, Florida. The District was formed in 1963 by a special act of the Legislature. At that time, the only developed area was the peninsular area of Alligator Point. Over the years, the District has added customers on Bald Point, Sun and Sands, and Dune Boulevard. The District currently provides water service to 128 customers outside its boundaries.

The District Board would like to request your support to expand our boundaries from what was created over 57 years ago. The Board would like the new district to include our well fields and areas that we already serve.

To complete this expansion, the Board needs the support of the Commission, the Local Legislative Delegation, conduct a public hearing, file a local bill with the Legislature, and finally, present the proposal for a vote of the Franklin County registered voters residing outside the District. **Those voters will be the ultimate decision-makers on this expansion proposal.**

There are a number of benefits to expanding the District's boundaries:

- * Lower monthly water bills for most customers currently outside the District
- * Increased fire protection and lower insurance rates
- * Hydrant In-Fill projects in areas with undersized lines
- * Ability for customers currently outside the District to serve on the APWRD board
- * Lower tap fees
- * Customers on private wells will NOT be forced to connect

APWRD has taxing authority within its District boundaries. The Board sets an annual millage rate based on the taxable value of property inside the District. Property owners pay a small portion of Ad Valorem taxes to APWRD to fund capital improvement items and maintain historically low water rates.

Customers who reside outside the District DO NOT pay Ad Valorem taxes to the District, but they must pay an annual \$360 surcharge to offset the difference (\$30/month). However, for those whose taxable property values are less than \$200,000, they are paying more with this surcharge. Page 6 of this presentation outlines the different amounts paid for those who live inside and outside the District based on their property value.

District Expansion will eliminate this surcharge so that all District customers, no matter where they reside, will pay the same rates for water and Ad Valorem taxes based on their property value.

Finally, with expansion the District will be able to provide more fire protection to these areas. Capital Improvement projects will not be restricted to only the areas that pay Ad Valorem taxes. The Board has shovel-ready projects in the Pine Street area for increasing water line sizes and adding more hydrants.

As always, we thank you for your time and consideration on our proposal and we hope that we can count on your support of Franklin County as we work together to serve the citizens of Franklin County.







Q: Will hookup to the Alligator Point Water system be mandatory if my property is included within the district boundaries?

No, residents will not be required to connect to the APWRD system. Should one chose to connect to the system, the district policy does requires customers to pay a onetime Access fee and Tap fee when applicable.

Q: What is the benefit to me to have my property included within the district boundaries?

Some of the benefits of having your property included within the district boundaries are:

- * Lower monthly water bill
- * Hydrant and fire protection
- * Ability to become an APWRD board member
- * Lower tap fees

Q: I was not able to vote last time the district expansion project was conducted. Why?

The referendum will be conducted for individuals who are registered to vote in Franklin County and own property outside of the current boundaries. Registered voters who live inside the current district will not be able to vote.

Q: Will I be required to abandon my own personal well?

No, however if you ever chose to connect to the APWRD system you will be required as an APWRD customer to have a backflow preventer. This is current APWRD policy and will not change with the passage of district expansion. The FDEP prohibits cross connection between approved potable source and a non-approved water source.

Q: Why do I have to have a backflow preventer for my own personal well if I am an APWRD customer? Who requires this?

If you are a current APWRD customer or potential customer and have an item such as a well, pool, or irrigation system then you are subject to the district's Cross Connection Policy. The Florida Department of Environmental Protection requires that backflow preventers be installed so that water is prevented from flowing "backwards" and contaminating an approved public water source. As a convenience to District customers, APWRD conducts annual inspections of all backflow preventers to ensure that they are working properly. The cost of installing the backflow device and the annual inspection fee is the responsibility of the customer. APWRD currently inspects backflows biennially in October and the inspection fee is \$45.00.

Q: Will my monthly water bill decrease if the vote passes?

If you are currently outside of the District then yes, Out-Of-District customers are currently charged a \$30 surcharge on top of their base rate. This fee covers the cost of providing service to customers outside the boundaries which customers inside the boundaries currently pay through their Ad Valorem taxes. Also, Tap fees are charged at a higher rate to outside the district customers so that fee will also be reduced with this passage.

Q: I am currently inside the district. Will my monthly water bill decrease if the vote passes?

No, customers inside of the District will not see any difference in their water rates.



Q: Will my overall expenses go up?

Customers outside of the District monthly expenses for water service will go down, but your ad valorem taxes may go up. For all customers, your overall expense will be determined depending on the taxable value of your property and the current millage rate set by the District during budget season. The taxable value for your property is set by the Franklin County Property Appraisers office and can be found on your annual TRIM notice or on their website. The District sets the millage rate based on the taxable value of property located within its District boundaries.

Q: If we are not on the APWRD system will we still be charged Ad Valorem taxes for the District?

Yes, the expansion will now include your property into the taxable value that the district uses to calculate the millage rate for the yearly budget.

Q: What if my property is a vacant lot; will I still be charged Ad Valorem taxes?

Yes, you will be charged based on the taxable value of your lot. Customers with vacant lots are still serviced by APWRD through fire protection whether they are district customers or not.

Q: What will the Board do with the revenue generated from Ad Valorem taxes on my property?

The Ad Valorem tax revenue is used to fund capital improvement items which are budgeted for prior to the beginning of the fiscal year. The APWRD partakes every year in the Florida Department of Revenue Truth In Millage process that requires the District to hold two public budget hearings. Residents are encouraged to attend these hearings and provide input to keep up to date on the upcoming projects and improvements that the APWRD is working on.

Q: Will my monthly water service I currently have change in any way?

No, your service will not be affected by this expansion.

Q: My property is already inside of the district. How will expansion effect my current water service?

If you are already a District customer then your service will not be affected by this expansion. The only effect expansion may have on you is a possible reduction in your ad valorem taxes. This will be dependent on the value that is added to the Districts current taxable value after the expansion is passed.

Q: Is the water that is provided to District customers tested for quality to ensure that it is safe and clean for consumption?

Yes, the Alligator Point water system is regulated by both Florida Department of Environmental Protection (FDEP) and the North West Florida Water Management District (NWFWMD). The District is required to provide yearly water quality reports to all district customers per FDEP regulations. The Consumer Confidence Report is available at the district office, on the district website, and is also published in the Apalachicola Times newspaper annually. APWRD takes water quality issues very seriously and staff is well trained to ensure that the water being supplied to customers meet both primary and secondary drinking water standards.

Q: How will my water service be affected by the busy holiday seasons?

APWRD is issued a Consumptive Use Permit by the NWFWMD that regulates the amount of water pumped per day, the average daily flow, and maximum day. During busy holidays, APWRD works to ensure that there is not a disruption in your water service. The water tanks are monitored to ensure that they don't go below a certain level. It is important to understand that APWRD does not let our

ground storage tanks run "dry" during busy holiday seasons. Staff continually reviews water pumping data to ensure customers are provided with clean sa H. Iter when they turn on their faucets.

Q: Why is the APWRD Board of Directors appointed by the Governor and not by the Alligator Point taxpayers?

The APWRD was created via an act of the Florida Legislature; therefore, it is not regulated by the Franklin County government or the taxpayers. Currently, only residents inside of the district boundaries are able to hold a seat on the board. With the passage of District expansion, customers that are currently outside of the boundaries will also be able to file an application with the Governors office to hold a seat. Board member positions are voluntary and un-paid.

Q: How many out-of-district customers does APWRD currently have?

Currently, the district has 127 outside of district customers and 650 total customers.



Board action to authorize the Planning Department to proceed with negotiations with Southeastern Consulting Engineers, Inc.

2. BOARD ACTION: Accept rankings of firms for CR370 Alligator Drive Multi-Use Path Phase I

The committee has ranked AECOM Technical Services, Inc. as the top firm for the CEI consultant on the CR370 Alligator Drive Multi-Use Path Phase I from George Vause Road to Gulf Shore Boulevard. As this project is federally funded through the Florida Department of Transportation LAP program, FDOT also needed to review and accept the rankings, which they have done so already.

Board action to authorize the Planning Department to proceed with negotiations with AECOM Technical Services, Inc.

3. BOARD ACTION: Approval to obtain easement for Eastpoint Channel Dredge Disposal Area

The Corps of Engineers, in consultation with FDEP, told Alan last week that Franklin County will need to obtain an easement from FDEP for the 26 acre Eastpoint Channel Disposal Area. An easement will be needed as the creation of the disposal area is going to turn currently submerged lands into an upland area. The county is already responsible for planting and stabilizing the area. The estimated fee for Dewberry to complete the necessary surveys and application will not exceed \$5,000 and can be paid out of the budget line item for professional services.

Board action to authorize Dewberry Engineers to complete the necessary surveys and application to obtain an easement from FDEP for access to the Eastpoint Channel Disposal Area.

4. BOARD ACTION: Approval to develop bird monitoring plan Two Mile Channel Dredge Project

The disposal area for the Two Mile Channel Dredge project is south of the Apalachicola Regional Airport. Alan was on a conference call last week with the Corps and the FAA and due to the proximity to the airport, the county will need to develop and implement a bird monitoring plan to satisfy the FAA. With approval from the Board, airport engineers AVCON can develop this plan and submit to county staff for review. The bird monitoring plan is going to require the Board to hire an FAA qualified biologist for this type of work. When the board dredged the Two Mile Channel some 15 years ago, this same requirement was in place. At that time, the Board contracted with FWC for

the use of a licensed 'Bird Harassment Officer' to be on-site during dredging to make sure birds did not congregate at the disposal site. The contract with FWC at that time was for about \$15,000.

Board action to authorize AVCON to develop and implement a bird monitoring plan to satisfy FAA requirements for use of the 2 Mile Channel Dredge Disposal Area.

5. BOARD ACTION: Use of CARES funds for Landfill Receiver Box Slab Pad

Of the first CARES allocation, Franklin County has a remaining balance of approximately \$61,000. At the Franklin County Landfill's transfer station, there is a 66'x33' concrete receiver box slab where the transfer containers for household waste are set to wait for transport to the Springhill landfill for disposal. This slab area was completed several years ago and prevents soil and groundwater contamination by draining the runoff from the transport containers to the sewer system. The containers are very heavy as is the equipment required to move the containers. To protect and preserve the concrete slab and the integrity of the drainage system, welded metal sheeting is needed for the pad area. The market prices of metal sheeting changes daily and the current estimate for the materials is \$29,178 with the necessary labor to install the sheeting estimated to be \$4,635. Does the Board want to consider using some of the balance of the first CARES allocation to preserve and protect the receiver box slab at the Landfill? The CARES expenditure worksheet is attached.

Board action to authorize the use of an estimated \$33,813 of the remaining proceeds from the 1st Cares Allocation to preserve and protect the receiver box slab at the landfill.

Informational Items

6. Board Information: Alligator Drive Hurricane Repair Project

At your last meeting, Alan informed the Board about an FDEP special permitting condition issue that had come up at the pre-construction meeting for the reconstruction of Alligator Drive. The subject special permit condition prohibited construction during Sea Turtle Nesting Season. Franklin County already had a letter from FWC acknowledging that there was no turtle nesting habitat in the area of construction so the special permit condition would and should not have applied, however, the FDEP staff on site were unable to waive the condition without moving up the chain of command at FDEP. Franklin County received formal approval/acknowledgement on Friday that this special permit condition would be waived by FDEP due to the lack of nesting habit. Dewberry Engineers can now move forward with issuing the Notice to Proceed for the reconstruction of Alligator Drive sometime this week.

7. Board Information: Buddy Ward Artificial Reef Project

Walter Marine of Orange Beach, AL will be in Franklin County on or around June 15th for deployment of the prefabricated articulated reef balls for the Buddy Ward Artificial Reef Project. The deployment is expected to be completed in one day and the Apalachicola Artificial Reef Association will be at the site to fully-document and monitor the deployment.

8. Board Information: Preliminary Estimate of Taxable Value

The Franklin County Property Appraiser has provided the Board with a good faith estimate of taxable value for use in the 2021/2022 budget cycle. In the attached, the estimated taxable value of property in Franklin County is \$2,310,915,668 which is an increase of 13.81% in value over the

previous year. This percentage of increase fueled by sales data and new construction is the fastest rate of appreciation as seen by Franklin County since the crash of the housing market almost fifteen years ago. The decline in values during the housing crash was so severe that the taxable value of property today is now just above the taxable value in 2004 which was \$2.107 billion and still 43% less than the taxable value at the high in 2006 when the taxable value was \$4.112 billion. The revenue estimates for state shared revenues and sales tax proceeds will not be released by the Florida Office of Economic Development and Research until sometime in July.



L. Report

Action Items

- 1. Airport Manager's Resignation: Mr. Jason Puckett submitted his resignation as your Airport Manager effective today June 1, 2021. My recommendation is to appoint me as your interim Airport Manager. This would allow the Board the opportunity to determine the role and responsibilities of a future Airport Manager, along with a job description and salary before advertising for a permanent candidate. I also recommend transferring the grant and reporting responsibilities, on a permanent basis, to Mrs. Erin Griffith, your Fiscal Manger/Grants Coordinator. Board action to accept Mr. Puckett's resignation, appoint me as the interim Airport Manager, and assign Airport grants and reporting to Mrs. Erin Griffith.
- 2.8 County Oil Spill Administrators' Meeting & Superintendent at July Meeting: I attended the 8 County Oil Spill Administrators' Meeting hosted by Senators Broxon and Gainer on Monday, May 24th. The purpose of the meeting was for all 8 counties to express concerns and suggestion regarding the TRIUMPH application process, with more funded projects as the end result. Job creations requirements, clawback clause, increase in infrastructure projects, and small county vs bigger county obstacles were discussed during a closed door session. Later that afternoon, the Senators invited TRIUMPH representatives, Chairman Don Gaetz, Mr. Rick Harper (Economist) and the Alan Manning General Council to the meeting and presented the concerns and suggestions discussed earlier. During the TRIUMPH representatives dialog and exchange of information, there was one suggestion from the representatives to the 8 counties, especially the smaller counties, include TRIUMPH in the early stages of planning or considering any project so they can assist with the application process. With that in mind, and based on an offer from Mr. Rick Harper (Economist) to meet with County representatives, I suggest that the Board consider authorizing Chairman Jones, Mrs. Erin Griffith, and I to meet with TRIUMPH representatives to discuss Franklin County's unique issues and perhaps generate some possible projects that TRIUMPH would consider. Board action to authorize Chairman Jones, Mrs. Griffith, and I to represent the Board and meet with TRIUMPH representatives to discuss possible projects.

Inform the Board that Mr. Steve Lanier, Superintendent of Schools, and I talked last week about the "adult vocational" program. Mr. Lanier along with his staff will be at your July 6th meeting to discuss this program in more detail.

3. Eastpoint USDA Grant: At your March 16, 2021 meeting the Board authorized the Eastpoint Civic Association, by Resolution, to apply for an USDA Rural Business Development Grant to complete an Eastpoint Highway 98 Waterfront and Business Corridor Feasibility Study. The Resolution authorized the elected officers of the Eastpoint Civic Association, Inc. to execute the grant application, agreement, change orders and other documents related to the grant as signatories for the County. However, Mrs. Betty Webb who made the initial presentation to the Board, is of the opinion that since the County is ultimate responsible party, the Chairman's signature is required on the application and related documents. The application is due in USDA's Marianna office tomorrow by 10 a.m. Mrs. Webb is available virtually to answer any questions. *Board action to authorize the*

Chairman's signature on the application and supporting documents for the USDA Rural Business Development Grant.

Informational Items

- 4. Courthouse Structure: Based on the Board's request, a structural engineer inspected the courthouse for any indication that undermining issues on Leslie or Forbes Street may cause structural issues in the courthouse. Mr. Lance Watson, Southeastern Consulting Engineers, does not believe that the issues on both roads present an immediate threat to the building's foundation because the are far enough away that they shouldn't impact the structure. However, he recommends that both roads are repaired as soon as possible to prevent further damage to the roadway and that the damage does not extend toward the Courthouse structure. There are some other issues that may have been caused by damaged infrastructure and recent hurricanes/storms that needs to be addressed. Mr. Watson and I will me in the near future to discuss addressing these issues. I will continue to update the Board on this matter.
- 5. SHIP Funding: Mrs. Lori Switzer-Mills, your SHIP Administrator, participated on a webinar on Thursday, May 20th were she was informed that the County will most likely receive \$350,000.00 for the 2021/22 SHIP allocation. She will update the Board once this information is confirmed.
- 6. NWFWMD: Attached is the Northwest Florida Water Management District's Annual Wetland report and summary. This report is based on the District's compilation of the status of wetland and related habitat protection in northwest Florida. It includes a cumulative summary of wetland impacts permitted by the Districts's Environmental Resource Permitting (ERP) program with a summary of wetlands and associated water resource lands restored and protected by District's programs.

The purpose of this correspondence is to provide an update for local government leaders and other interested parties about the status of wetland and related habitat protection in northwest Florida. Wetland Environmental Resource Permitting (ERP) has been implemented in northwest Florida since November 1, 2010. Additionally, the Northwest Florida Water Management District (NWFWMD) began in 1996 to implement a regional wetland mitigation program to support Florida Department of Transportation (FDOT) projects.

As of December 31, 2020, impacts to approximately 474 acres of wetlands have been permitted across northwest Florida through the District's ERP program, and impacts to nearly 524 acres have been permitted to support FDOT projects. Through this date, multiple NWFWMD programs have together protected over 169,000 acres of wetlands and restored over 30,400 acres of wetlands and adjacent protective uplands. Within Franklin County, approximately seven acres of wetland impacts have been permitted, corresponding with approximately 617 acres of restoration and nine acres of preservation. Additional information is provided in the enclosed table.

Please note that the areas indicated here reflect impacts, preservation, and restoration associated with Northwest Florida Water Management Programs only. Significant additional areas of habitat have been protected and restored by other public agencies and private nonprofit organizations.

Action Items for June 1, 2021

1. <u>Settlement:</u> Two claims are pending against the Weems EMS. A settlement has been reached without any admission of liability, but your insurance has agreed to settlement terms. The county's only financial responsibility will be payment of two \$5,000.00 deductibles. I recommend that you accept the insurance company's recommendation. I have discussed the terms of the settlement with each you individually.

Board Action Requested: Accept the two settlements recommended by the insurance companies.

2. <u>Enhanced Cleaning of Vacation Rentals:</u> Last year around this time, the board adopted an enhanced cleaning program for vacation rentals so that they could re-open. Now that the Governor has eliminated all China Virus related restrictions, the board should reconsider officially disposing of the enhanced cleaning protocol for vacation rentals.

<u>Board Action Requested:</u> Discussion and decision regarding enhanced cleaning program for vacation rentals in Franklin County.

3. Land Swap Proposed by City of Apalach and Land Trust and Request to Release Reverter Clause: The City of Apalach and the Land Trust propose to swap one 60'x100' given by Franklin County to the Land Trust (subject to a reverter clause) for affordable housing to the City in exchange for four 30'x100' lots. For purposes of the City's land development code, the four lots equal two 60'x100' lots; representing two buildable lots being exchanged for one buildable lot.

In 2010, Franklin County donated the one 60'x100' lot to the Land Trust for affordable housing, subject to a reverter clause which automatically transfers title back to Franklin County if the Land Trust uses it for any other purpose than affordable housing or transfers title. Thus, their request that Franklin County release the reverter clause.

I believe that the wants the Land Trust to donate the 60'x100' lot without condition, but on May 29, 2021, I asked for the City Manager and City Attorney to provide me with a written position on this matter.

Board Action Requested: Discussion and decision on the request for a land swap.

Non-Action Items
