### NOTICE TO RECEIVE SEALED BIDS

The Franklin County Board of County Commissioners will receive sealed bids from any qualified person, company or corporation interested in constructing:

#### SGI STORMWATER DRAINAGE IMPROVEMENTS

The project consists of improvements to the St. George Island Stormwater System. These improvements include but are not limited to the addition of new stormwater pipes, stormwater structure, and the construction of new stormwater ponds. These improvements will be located on St. George Island from approximately 3<sup>rd</sup> Street West to 3<sup>rd</sup> Street East.

All bidders shall be FDOT qualified per Section 2-1 of the FDOT Standard Specifications for Road and Bridge Constructions, latest edition in the following work classes: Grading, Drainage, Flexible Paving, and Hot Plant Mix-Bituminous Course.

Completion date for this project will be 210 days from the date of the Notice to Proceed presented to the successful bidder. Liquidated damages for failure to complete the project on the specified date will be set at \$250.00 per day.

Please indicate on the envelope that this is a sealed bid, for “**SGI STORMWATER DRAINAGE IMPROVEMENTS**”.

Bids will be received until 4:30 p.m. eastern time, on Monday, November 4<sup>th</sup>, 2024, at the Franklin County Clerk's Office, 33 Market Street, Suite 203, Apalachicola, Florida 32320-231, and will be opened and read aloud on Tuesday, November 5<sup>th</sup>, 2024, at the County Commission meeting held at 34 Forbes Street, Apalachicola, FL.

The Board of County Commissioners reserves the right to waive informalities in any bid, to accept and/or reject any or all bids, and to accept the bid that in their judgment will be in the best interest of Franklin County. All bids shall remain firm for a period of sixty days after the opening.

All bidders shall comply with all applicable State and local laws concerning licensing registration and regulation of contractors doing business to the State of Florida.

A **mandatory** pre-bid meeting will be held adjacent to the project site at the main parking area for Lighthouse Park, 2 East Gulf Beach Drive, St. George Island on October 18<sup>th</sup>, 2024, at 10:00 Eastern time.
