

**AN ORDINANCE REZONING 10.00 ACRES OF PRIVATE REAL PROPERTY
IN SECTION 30, TOWNSHIP 5 SOUTH, RANGE 7 WEST, FROM R-6 RURAL
RESIDENTIAL TO R-3 SINGLE FAMILY ESTATE RESIDENTIAL.**

**ORDINANCE 2000- 18
FRANKLIN COUNTY, FLORIDA**

WHEREAS, the Board of County Commissioners of Franklin County, Florida has received a recommendation from the Franklin County Planning and Zoning Commission for rezoning certain private real property, and

WHEREAS, the Board of County Commissioners of Franklin County has conducted a public hearing with due public notice,

NOW, THEREFORE, BE IT ORDAINED BY THE FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS that:

A parcel of private real property, containing 10.00 acres and described below, as shown on the attached map, is rezoned from R-6 Rural Residential to R-3 Single Family Estate Residential.

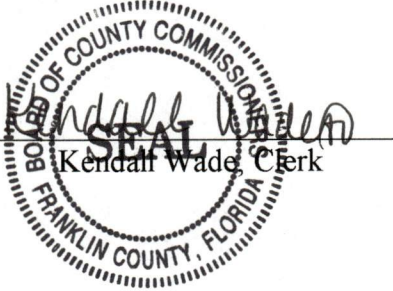
Commence at a government concrete monument marking the Southeast corner of Section 30, Township 5 South, Range 7 West, Franklin County, Florida, and run North 89 degrees 16 minutes 35 seconds West 1388.62 feet, thence run North 00 degrees 36 minutes 17 seconds East 1338.17 feet to the POINT OF BEGINNINGS. From said POINT OF BEGINNING thence run North 89 degrees 16 minutes 35 seconds West 651.04 feet, thence run North 14 degrees 07 minutes 45 seconds West 325.42 feet, thence run North 39 degrees 14 minutes 53 seconds East 613.20 feet to the centerline of a 60.00 foot ingress, egress and utility easement, thence run along said centerline as follows: South 55 degrees 23 minutes 12 seconds East 343.28 feet to a point of curve to the right, thence Southeasterly along said curve with a radius of 150.49 feet thru a central angle of 55 degrees 59 minutes 29 seconds for an arc distance of 147.06 feet, thence South 00 degrees 36 minutes 17 seconds West 478.26 feet to the POINT OF BEGINNING containing 10.00 acres, more or less.

This Ordinance adopted this 15TH day of AUGUST, 2000, in a regular meeting of the Franklin County Board of County Commissioners after giving notice of intent to adopt it as a rezoning of less than 5 % of the County. This Ordinance shall take effect when notice of receipt of a certified copy of same is returned from the Secretary of State.

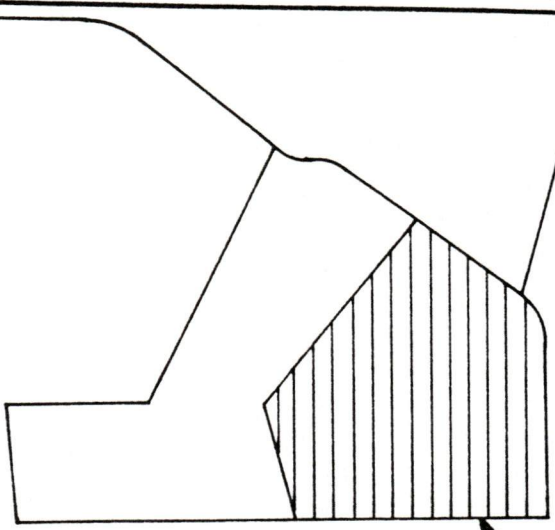
