

AN ORDINANCE REZONING 348 ACRES OF REAL PROPERTY IN SECTIONS 9 AND 16, TOWNSHIP 7 SOUTH, RANGE 4 WEST, FROM A-2 FORESTRY AGRICULTURE TO Z-1 PUBLIC FACILITIES.

**ORDINANCE 99-16
FRANKLIN COUNTY, FLORIDA**

WHEREAS, the Board of County Commissioners of Franklin County, Florida has received a recommendation from the Franklin County Planning and Zoning Commission for rezoning certain real property, and

WHEREAS, the Board of County Commissioners of Franklin County has conducted a public hearing with due public notice,

NOW, THEREFORE, BE IT ORDAINED BY THE FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS that:

The zoning on the following described parcel of real property, as shown on the attached map, is changed from A-2 Forestry Agriculture to Z-1 Public Facilities.

A parcel of land lying in Sections 9 and 16, Township 7 South, Range 4 West, Franklin County, Florida, being more particularly described as follows:


Beginning at the Northwest corner of said Section 16, thence along the West line of said Section 9, N 01°10'07"E, 239.26 feet to a point of intersection with the Southerly right-of-way line of State Road 67; thence along said Southerly right-of-way line, N 62°44'37"E, 1393.20 feet to a point of curvature thence Northeasterly along said Southerly right-of-way line, along the arc of said curve, having a radius of 1482.69 feet, a central angle of 40°58'26", an arc length of 1060.32 feet (chord to said curve bears N 42°15'25"E, 1037.87 feet) to a point on the arc of a non-tangent curve concave to the Southwest; thence leaving said right-of-way line, Southeasterly along the arc of said non-tangent curve, having a radius of 1745.96 feet, a central angle of 14°07'16", an arc length of 430.31 feet (chord to said curve bears S 49°51'35"E, 429.22 feet); thence S 35°18'09"E, 167.48 feet to a point on the arc of a non-tangent curve concave to the Northeast; thence Southeasterly along the arc of said non-tangent curve, having a radius of 982.10 feet, a central angle of 22°36'58", an arc length of 387.66 feet (chord to said curve bears S 50°37'13"E, 385.15 feet); thence S 01°53'14"W, 6076.16 feet; thence N 89°51'49"W, 2561.70 feet to a point on the West line of said Section 16; thence along said West line, N 01°06'14"E, 5080.03 feet to the POINT OF BEGINNING.

This Ordinance adopted this 7th day of September, 1999, in a regular meeting of the Franklin County Board of County Commissioners after giving notice of intent to adopt it as a rezoning of less than 5% of the County. This Ordinance shall take effect when notice of receipt of a certified copy of same is returned from the Secretary of State.
