TOWNSHIP 8 SOUTH, RANGE 5 WEST, LYING NORTH OF HIGHWAY 98
BETWEEN EASTPOINT AND CARRABELLE, FRANKLIN COUNTY, FLORIDA
FROM R-6 RURAL RESIDENTIAL TO R-1 SINGLE FAMILY RESIDENTIAL.**

WHEREAS, the Board of County Commissioners of Franklin County, Florida has received a recommendation from the Franklin County Planning and Zoning Commission for rezoning certain private real property, and

WHEREAS, the Board of County Commissioners of Franklin County has conducted a public hearing with due public notice,


NOW, THEREFORE, BE IT ORDAINED BY THE FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS that:

A 10 acre parcel lying in Section 18, Township 8 South, Range 5 West, lying north of Highway 98 between Eastpoint and Carrabelle, Franklin County, Florida is rezoned from R-6 Rural Residential to R-1 Single Family Residential.



Begin at the intersection of the West boundary of Section 18, Township 8 South, Range 5 West, Franklin County, Florida with the Northwesternly right-of-way boundary of U. S. Highway No: 98. From said POINT OF BEGINNING and leaving said right-of-way boundary run North 00 degrees 45 minutes 28 seconds East along the West boundary of said Section 18 a distance of 706.49 feet, thence run North 00 degrees 47 minutes 28 seconds East along said Section line 943.24 feet, thence run South 89 degrees 15 minutes 05 seconds East 213.95 feet, thence run South 00 degrees 47 minutes 28 seconds West 808.81 feet, thence run North 57 degrees 18 minutes 20 seconds East 108.51 feet, thence run South 00 degrees 47 minutes 28 seconds West 328.13 feet, thence run South 42 seconds 30 minutes 54 seconds East 60.89 feet, thence run South 32 degrees 41 minutes 40 seconds East 250.00 feet to point lying on the Northerly right-of-way boundary of U. S. Highway No: 98, thence run South 57 degrees 18 minutes 20 seconds West along said right-of-way boundary 580.00 feet to the POINT OF BEGINNING containing 10.00 acres more or less.
