

AN ORDINANCE AMENDING THE FRANKLIN COUNTY COMPREHENSIVE PLAN TO CHANGE THE PERMITTED LAND USE OF LOTS 1, 2, 3, 6 & A PORTION OF LOT 4 OF DAVID BROWN ESTATES LOCATED IN EASTPOINT FROM RESIDENTIAL TO COMMERCIAL.

**ORDINANCE 2003- 23
FRANKLIN COUNTY, FLORIDA**

WHEREAS, the Board of County Commissioners of Franklin County, Florida has received a recommendation from the Franklin County Planning and Zoning Commission for changing the land use of a certain parcel of private real property, and


WHEREAS, the Board of County Commissioners of Franklin County has conducted a public hearing with due public notice,

NOW, THEREFORE, BE IT ORDAINED BY THE FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS that:

The permitted land use of lots 1, 2, 3, 6, & a portion of lot 4 of David Brown Estates located in Eastpoint, as shown on the attached map and described in attachment A is changed from Residential to Commercial.

This Ordinance adopted this 17th day of June, 2003, in a regular meeting of the Franklin County Board of County Commissioners after notice was duly given, and pursuant to Chapter 163, Florida Statutes.

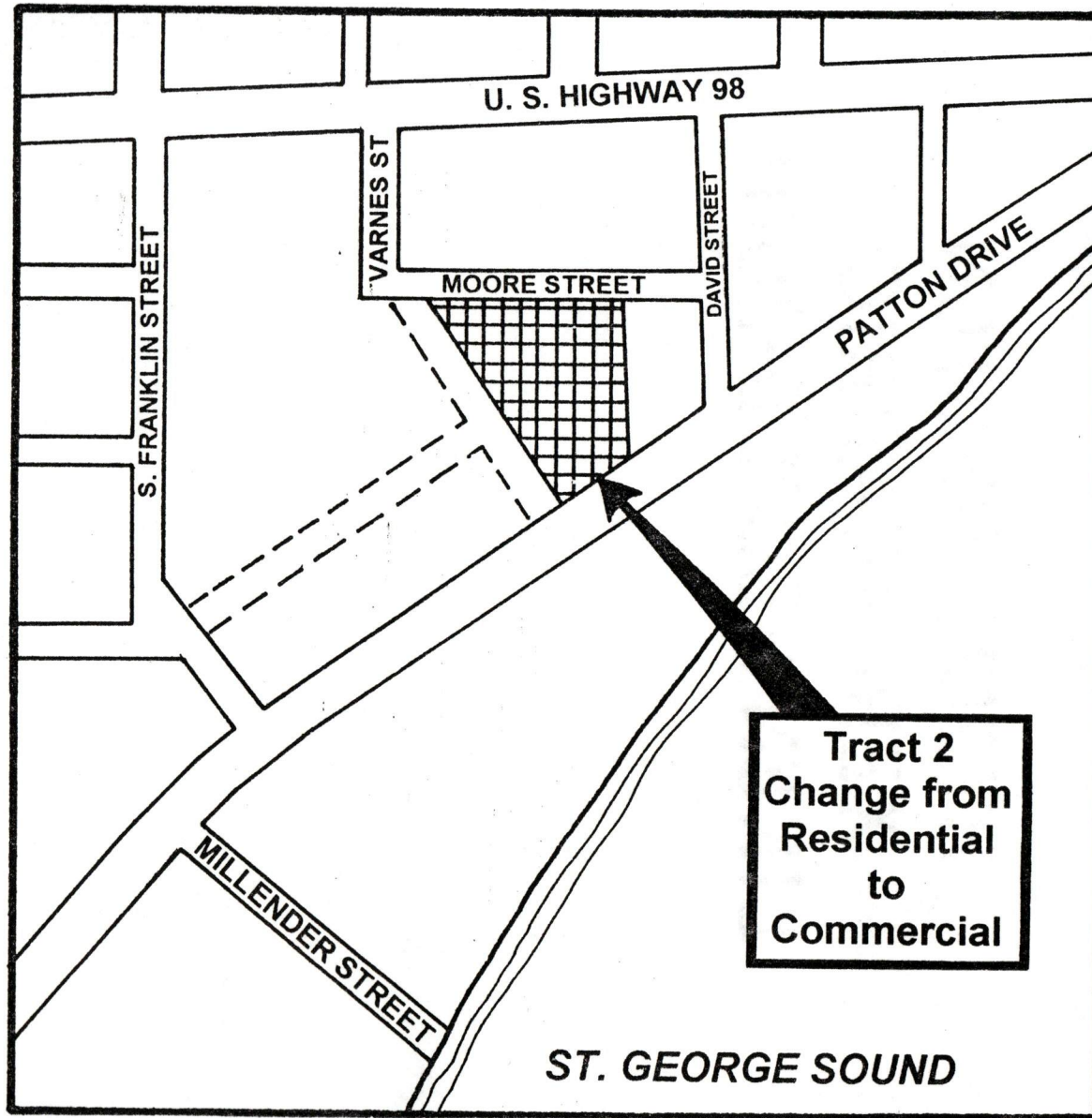
Begin at the Northwest corner of Lot 1, Block "4" of David H. Brown Estates, Inc. Addition to Eastpoint, a subdivision as per map or plat thereof recorded in Plat Book 3, Page 4 of the Public Records of Franklin County, Florida and thence run South 89 degrees 59 minutes 30 seconds East along the Northerly boundary of said Block "4" and along the Southerly right-of-way boundary of Avenue "C" 421.73 feet to a concrete monument, thence run South 00 degrees 07 minutes 42 seconds West 346.02 feet to a re-rod on the Northerly right-of-way boundary of State Road No. S-65, thence run South 55 degrees 56 minutes 47 seconds West along said right-of-way boundary 153.04 feet to a concrete monument, thence run North 34 degrees 15 minutes 54 seconds West along the Easterly right-of-way boundary of Adams Street (not open) 522.46 feet to the POINT OF BEGINNING containing 2.59 acres, more or less. Situate, lying and being in Section 31, Township 8 South, Range 6 West, Franklin County, Florida.

The undersigned surveyor has not been provided a current title opinion or abstract of matters affecting title or boundary to the subject property. It is possible there are deeds of records, unrecorded deeds, easements or other instruments which could affect the boundaries.
