

ORDINANCE NO. 96-7

FRANKLIN COUNTY, FLORIDA

AN ORDINANCE OF FRANKLIN COUNTY, FLORIDA, ENACTED AS  
AN EMERGENCY ORDINANCE; WAIVING NOTICE;  
PROVIDING THAT COUNTY ROAD C-65, ALSO KNOWN AS PATTON DRIVE  
BE SUBJECT TO A 25 MILES PER HOUR SPEED LIMIT AND THAT  
TRUCK TRAFFIC THROUGH C-65 FROM STATE ROAD 30 (U.S. 98)  
TO ISLAND DRIVE IS PROHIBITED; ALLOWING TRUCK TRAFFIC  
WITHIN THE "NO THROUGH TRUCKS" ZONE;  
PROVIDING A PENALTY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Franklin County, Florida finds upon the recommendation of the County Engineer that an emergency exists due to vehicles traveling at excessive speed, and due to use by trucks travelling through County Road 65 in Eastpoint, Florida and

WHEREAS, Franklin County Board of County Commissioners by unanimous vote, declare that an emergency exists and waived notice requirements of Section 125.66(2), because the immediate enactment of this ordinance is necessary.

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF FRANKLIN COUNTY:

1. County Road C-65, also known as Patton Drive, in Eastpoint, from State Road 30 (U.S. 98) to Island Drive, shall be subject to a 25 miles per hour speed limit, and shall be closed to through truck traffic.

2. The proper traffic signs shall be placed according to law, on the designated road.

3. Truck traffic to destinations within the limits of the designated road is not prohibited hereby.

4. Violation of this Ordinance shall be punishable as a misdemeanor, by fine not exceeding \$500.00 or imprisonment in the County Jail not to exceed 60 days, or by both such fine and imprisonment, or this Ordinance may be enforced as a traffic violation according to state law.

5. This Ordinance shall become effective when a certified copy hereof has been accepted by the postal authorities of the United States for special delivery by certified mail to the Department of State.
