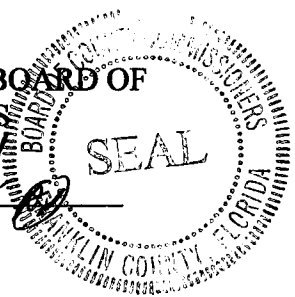
The permitted zoning of a 10 acre parcel lying in Section 23, Township 6 South, Range 4 West, north of Carrabelle, Franklin County, Florida, as shown on the attached map is changed from A-2 Forestry Agricultural to R-6 Rural Residential.

EXHIBIT A

Commence at a concrete monument (marked #4261) marking the intersection of the South boundary of Section 22, Township 6 South, Range 4 West, Franklin County, Florida with the Easterly right-of-way boundary of State Road No: S-67 and run North 10 degrees 24 minutes 28 seconds West along said Easterly right-of-way boundary 2642.60 feet to a re-rod (marked #4261), thence leaving said right-of-way boundary run North 89 degrees 59 minutes 46 seconds East 3440.04 feet to a concrete monument (marked #7160) lying on the Easterly right-of-way boundary of Hickory Hammock Road, thence leaving said Easterly right-of-way boundary continue North 89 degrees 59 minutes 46 seconds East 1364.21 feet to a concrete monument (marked #7160), thence run South 05 degrees 57 minutes 06 seconds East 405.26 feet to an iron rod and cap (marked #7160) marking the POINT OF BEGINNING. From said POINT OF BEGINNING continue South 05 degrees 57 minutes 06 seconds East 335.43 feet to an iron rod and cap (marked #7160), thence run South 83 degrees 15 minutes 50 seconds West 1285.43 feet to an iron rod and cap (marked #7160) lying on the Easterly right-of-way boundary of Hickory Hammock Road, thence run North 10 degrees 29 minutes 58 seconds West along said Easterly right-of-way boundary 336.12 feet to an iron rod and cap (marked #7160), thence leaving said right-of-way boundary run North 83 degrees 15 minutes 50 seconds East 1312.08 feet to the POINT OF BEGINNING containing 10.00 acres, more or less.
